Attached is the Annual Report pursuant to the requirements of the Ventura County Municipal Stormwater NPDES Permit No. CAS004002/Order No. 10-108 which requires an Annual Storm Water Report (Report) to be submitted by December 15th of each year. This Report discusses the Permittees' Permit compliance activities for the period of July 1, 2013 to June 30, 2014 and includes a description of all activities conducted during the reporting period, an assessment of the Ventura Countywide Stormwater Program's effectiveness, and an evaluation of pollutants detected through the Stormwater Monitoring Program.

This Annual Report was prepared with the cooperation and assistance of the Ventura Countywide Permittees which includes the cities of Camarillo, Fillmore, Moorpark, Ojai, Oxnard, Port Hueneme, Ventura, Santa Paula, Simi Valley, Thousand Oaks, the County of Ventura, and the Ventura County Watershed Protection District. Each Permittee contributed detailed Permit compliance information and data regarding their various stormwater programs.

Beach water quality in Ventura County was once again among the best in the state. Some notable accomplishments by the Program and the Permittees this reporting period include: initiating a bacteria genetic source marker study, additional aluminum sampling and historical data analysis, revised pesticide protocol, and undertaking a unified countywide geodatabased storm drain atlas for future watershed planning efforts.



To help communicate the Program's accomplishments, lessons learned, and the future of the Ventura Countywide Stormwater Program, I would like to extend an invitation to you and your staff to meet and discuss this report and our upcoming Permit renewal at your earliest convenience in 2015.

I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted. On file at the Ventura County Watershed Protection District is the same signed statement from each of the Permittees.

I am aware that there are significant penalties for submitting false information, including the possibility of a fine and imprisonment for knowing violations.
