Dear Mr. Unger:

Attached is the Annual Report pursuant to the requirements of the Ventura County Municipal Stormwater NPDES Permit No. CAS004002/Order No. 10-108 which requires an Annual Storm Water Report (Report) to be submitted by December 15th of each year. This Report discusses the Permittees' Permit compliance activities for the period of July 1, 2011 to June 30, 2012 and includes a description of all activities conducted during the reporting period, an assessment of the Ventura Countywide Stormwater Program's effectiveness, and an evaluation of pollutants detected through the Stormwater Monitoring Program.

All of our stormwater Program efforts from July 1, 2011 through June 30, 2012 are included in this Report. On July 8, 2010, Order No. R4 2010-0108 was adopted with minor changes. The 2010 Permit replaced Order No. 09-0057 in its entirety, and all references to the Permit in this Report refer to that Order.

This Annual Report was prepared with the cooperation and assistance of the Ventura Countywide Permittees which includes the cities of Camarillo, Fillmore, Moorpark, Ojai, Oxnard, Port Hueneme, Ventura, Santa Paula, Simi Valley, Thousand Oaks, the County of Ventura, and the Ventura County Watershed Protection District. Each Permittee contributed detailed Permit compliance information and data regarding their various stormwater programs.


