ANNUAL REPORT 2012/13 - VENTURA COUNTYWIDE MUNICIPAL STORMWATER PERMIT AND PROGRAM, ORDER NO. R4-2010-108 (NPDES PERMIT NO. CAS004002)

Dear Mr. Unger:

Attached is the Annual Report pursuant to the requirements of the Ventura County Municipal Stormwater NPDES Permit No. CAS004002/Order No. 10-108 which requires an Annual Storm Water Report (Report) to be submitted by December 15th of each year. This Report discusses the Permittees' Permit compliance activities for the period of July 1, 2012 to June 30, 2013 and includes a description of all activities conducted during the reporting period, an assessment of the Ventura Countywide Stormwater Program's effectiveness, and an evaluation of pollutants detected through the Stormwater Monitoring Program.

This Annual Report was prepared with the cooperation and assistance of the Ventura Countywide Permittees which includes the cities of Camarillo, Fillmore, Moorpark, Ojai, Oxnard, Port Hueneme, Ventura, Santa Paula, Simi Valley, Thousand Oaks, the County of Ventura, and the Ventura County Watershed Protection District. Each Permittee contributed detailed Permit compliance information and data regarding their various stormwater programs.

Beach water quality in Ventura County was once again among the best in the state. Some notable accomplishments by the Program and the Permittees this reporting period include: a Program update presentation to your Board; support for the development of a plastic bag ban environmental impact report; development of a water quality index to distill over 200 constituents into an easily understood value; development of a Hydromodification Control Plan; a new data visualization website to communicate our water quality to the public, and an upgrade of the public outreach website.
