Subject: **ANNUAL REPORT 2009/2010 - VENTURA COUNTY-WIDE MUNICIPAL
STORMWATER PERMIT AND PROGRAM**

Dear Mr. Unger:

Attached is the Annual Report pursuant to the requirements of the Ventura County Municipal Stormwater NPDES Permit No. CAS004002/Order No. 10-108 which requires an Annual Storm Water Report (Report) to be submitted by December 15th of each year. This Report discusses the Permittees' Permit compliance activities for the period of July 1, 2009 to June 30, 2010, includes a description of all activities conducted during the reporting period, and an assessment of the Ventura Countywide Stormwater Program's effectiveness.

Order No. 09-0057 was adopted on May 7, 2009. That Permit became effective on August 7, 2009, and was not technically in effect for the first month of the reporting period; however the Permittees started work on implementing the conditions of the new Permit immediately. For reporting purposes all of our stormwater Program efforts from July 1, 2009 through June 30, 2010 are included in this Report.

As you know, after the May 7, 2009 adoption of the permit the Regional Board voluntarily remanded the Permit for a new adoption hearing. On July 8, 2010 Order No. R4 2010-0108 was adopted with minor changes. The 2010 Permit replaced the Order No. 09-0057 in its entirety, and all references to the Permit in this Report refer to that Order.

This Annual Report was prepared with the cooperation and assistance of the Ventura Countywide Co-permittees who contributed the detailed Permit compliance information and data regarding their various stormwater programs.

I certify under penalty of law that this document and all attachments were prepared under my direction or supervision in accordance with a system designed to assure that qualified personnel properly gather and evaluate the information submitted.
